Everything from color case hardening a receiver or frame to slow rust or hot bluing the barrel and metal, to refinishing a stock. It is included in the price for Complete Restorations.

I use Mr. Jack Jones, Master Engraver.

There is a \$100.00 minimum charge for CCH of small parts such as triggers, hammers or screws.

To dis-assemble & re-assemble the parts from your frame/receiver only: \$100.00

To dis-assemble &  
re-assemble the whole firearm is: \$200.00

There is also a \$55.00 per hour charge for hand polishing. Once I receive the firearm I will make the determination & quote you as such.
